The main mission of the Market Surveillance is to ensure the fairness and integrity of the trading activity on all EPEX SPOT markets and to monitor that market participants do not distort market prices by infringing EPEX SPOT Rules and Regulations. This helps all actors of the energy sector having confidence in EPEX SPOT trading prices.

Market Surveillance defines the EPEX SPOT Code of Conduct, which describes the set of trading behaviors to be adopted by market participants at all time in order to comply with European Regulation on Energy Trading (REMIT).

This internship will enable you to understand how this team is monitoring our markets every day and how the reporting is done to the competent authorities. It will also give you a privileged understanding of the inner workings of the energy sector from the economical and technical perspectives.

Depending on your profile, your missions can be adapted and might include the following tasks:

- Technical and economical market analysis and ad-hoc studies
- Creation of a database aggregating various elements to better classify the trading behaviours and consequently to improve our alert based detection

- Suggestion of improvements for our market monitoring and investigations through different approaches, i.e. automation process, benchmarks, specific reporting
- Maintenance and update of our current market surveillance tools
