### Reminder – Auction process

From 10 days before Auction Closure Day (D-10) participants can transfer their guarantees to the ECC account at the RTE registry. The RTE registry is open from 07:00<sup>1</sup> to 19:00, excluding weekends and public holidays. Please be aware that transfers in the registry need to be initiated before 10:00 to be tradable in CTS (EPEX' Capacity Trading System) on the same ECC business day at 16:00. After 10:00, transfers will be credited on the next ECC business day at 16:00. The deadline for the last CG transfer to ECC's RTE registry account is set at 10:00 1 day before Auction Closure Day (D-1). Participants can also negotiate their financial limit with their Clearing Bank, which will then enter it into ECC's system. The deadline for setting a financial limit is at 16:00 1 day before Auction Closure day (D-1).

Please make sure to set your limits in advance of these deadlines. From 7 days before Auction Closure Day (D-7) at 10:00 to Auction Closure Day at 10:00, participants can send their orders via the CTS platform. Order books close and the auction runs at 10:00 on Auction Day, which is always a Thursday.

For those concerned by the certification process with RTE, please make sure to start it well ahead of the auction within the deadlines set by RTE.
